Visit **LakeVoterPower.info** to confirm you are registered, find early and Election Day voting sites, and preview your official ballot. Whether voting early, by mail, or on Election Day, you must be registered to vote. Voters with special needs can mark their ballot privately and unassisted using accessible terminals.

Illinois law requires a completed application before a voter can receive a ballot by mail. You can complete an online application or download a paper version by clicking on the "Request a Ballot by Mail" tab after logging into **LakeVoterPower.info**. Applications may also be requested via e-mail at **VotingByMail@lakecountyil.gov** or calling 847.377.2406.
