This work includes the widening of Hunt Club Road at IL Route 132 to provide dual left turns and a dedicated right turn lane on all four legs, resurfacing, traffic signal improvements, ADA improvements, landscaping, and other related items. The work consists of placement of polymerized HMA surface course, removal of HMA surface, placement of polymerized leveling binder, ADA curb ramp improvements, sodding, traffic signal items, and other related items.
