#### **CITY OF HIGHWOOD**

Public Question Regarding The City Of Highwood Clerk

Shall the Clerk of the City of Highwood be appointed by the Mayor, with the advice and consent of the City Council, rather than elected?

#### **VILLAGE OF ROUND LAKE**

Public Question Regarding Village Of Round Lake Village Clerk

Shall the Village Clerk in the Village of Round Lake, Illinois be appointed by the Village President with the advice and consent of the Village Board of Trustees, rather than elected, effective upon passage of this referendum?

#### **VILLAGE OF WAUCONDA**

Advisory Referendum

Shall the Board for the Village of Wauconda, Illinois approve the storyboards for the Heroes of Freedom Memorial as last proposed by the Heroes of Freedom Memorial Committee to include the actions of the United States Armed Forces in the Global War on Terrorism, the Iraq War and the War in Afghanistan?

#### **ANTIOCH C.C. SCHOOL DISTRICT #34**

Proposition To Establish Debt Service Extension Base

Shall the debt service extension base under the Property Tax Extension Limitation Law for Antioch Community Consolidated School District Number 34, Lake County, Illinois, for payment of principal and interest on limited bonds be established at \$1,400,000 for the 2017 levy year and all subsequent levy years?

#### **DIAMOND LAKE SCHOOL DISTRICT #76**

Proposition To Issue \$11,400,000 School Building Bonds

Shall the Board of Education of Diamond Lake School District Number 76, Lake County, Illinois, alter, repair and equip school buildings to provide safety and security, mechanical, infrastructure, restroom, library and gymnasium improvements, improve the sites thereof and issue bonds of said School District to the amount of \$11,400,000 for the purpose of paying the costs thereof?

## **HAWTHORN C.C. SCHOOL DISTRICT #73**

Proposition To Issue \$42,000,000 School Building Bonds

Shall the Board of Education of Hawthorn Community Consolidated School District Number 73, Lake County, Illinois, build and equip additions to, improve the sites of and alter, repair and equip school buildings, including to provide STEM facilities; acquire and improve a site; and issue bonds of said School District to the amount of \$42,000,000 for the purpose of paying the costs thereof?

## **COMMUNITY HIGH SCHOOL DISTRICT #117**

Proposition To Elect Board Members At-Large

Shall members of the Board of Education of Community High School District #117, Lake County, Illinois, be elected in 2019 and thereafter, at large and without restriction by area of residence within the District instead of the current restriction which requires that two Board of Education members reside in the unincorporated territory in the District?

## **ROCKLAND FIRE PROTECTION DISTRICT**

Proposition To Elect The Trustees Of The Rockland Fire Protection District

Shall the trustees of the Rockland Fire Protection District be elected, rather than appointed?
