### **Civil Service Fee:**

- All fees listed are for attempted service of documents for (1) person at (1) address. Fee service for the same case number will accrue a \$15.00 fee for EACH additional person residing at the same address.
- Add \$1.00 for each person served using paperwork originating outside the State of Illinois.
- Service fees include the scheduling and posting of court orders for Evictions and Replevins.

### **Eviction Enforcement Fee:**

- Eviction enforcement fees cover the cost of the first hour of the eviction. **Each additional hour will be billed at \$124 per hour. Additional fees may be assessed in circumstances requiring additional deputies.**
- **Eviction rescheduling fee is \$109.00 per occurrence.**  
If you choose to cancel an eviction, you MUST CANCEL no later than 1 hour prior to the eviction or you will be billed for the first hour.

### **Replevin Enforcement Fee:**

- Replevin enforcement fees cover the cost of the first hour of the replevin.
- **Each additional hour will be billed at \$124 per hour.**

### **Tax Notices**

- Service fee for in-county service
- \$7.00 for each out-of-county certified mailing

### **Boat Lien:**

- Service fee + \$150.00 for all sales
- \$7.00 for each certified mailing
- \$75.00 for all cancelled sales

### **Levy:**

- Judgements up to \$1,000, a levy fee of \$ 90.00
- Judgements over \$1,000 - \$15,000, a levy fee of \$275.00
- Judgements over \$15,000, a levy fee of \$400.00

### **Real Estate Levy Fee for Sale of Property:**

- Service fee + \$500.00 fee for sale of property + \$58.00 fee for recording and releasing levy with the Recorder of Deeds Office
