A “health” or “medical” home is not a building, house or hospital, but rather an approach to providing comprehensive primary care. A medical home is defined as primary care that is:

- Accessible
- Continuous
- Comprehensive
- Family centered
- Coordinated
- Compassionate
- Culturally effective

Spread across 50 states, community health centers provide “healthcare homes” that increase access to care, improve health outcomes for patients and reduce health disparities.

The Lake County Community Health Center provides high quality, comprehensive healthcare that is accessible, coordinated, community directed and culturally sensitive.

Getting Started

For any non-life threatening health needs, the in-take staff will guide you to the resources you need.

Eligibility

- All Lake County residents.
- Third party billing for Medicaid, Medicare or private insurance is available.
- Clients may qualify for a reduced fee by completing a sliding fee scale application.
- Payment plans.
- **No one is denied services due to inability to pay.**

Health Center Costs

While all health centers must provide access to services without regard for a person's ability to pay, services are not free. Rather, health centers have a set schedule of fees and corresponding discounts (often referred to as a sliding fee scale) for the services they provide. The sliding fee scale is based on a patient's ability to pay and family size according to the most recent federal poverty guidelines.

When you make your appointment, staff will inform you about required documents you will need to bring such as pay check stubs.

If you have a life threatening situation, dial 911 or go to your nearest hospital emergency room.

Community Health Center Programs

Adult and Pediatric Medicine

Available at all Community Health Centers
Medical care, including preventive care, chronic illness care and acute illness care, is provided to adults. Healthy baby care, immunizations, development assessments, lead testing and referrals are also provided for infants and children.

Women's Health Program

Available at all Community Health Centers
Women's health services provide comprehensive service for women of all ages. Programs include family planning, prenatal and delivery and gynecological care. Services include counseling, education, medical examinations and laboratory testing.

Dental Program

Available at all sites except the Northeast Health Center
Services include clinical dentistry, prevention services and nursing home dental care.

Mental Health Program

Available at the Belvidere and Grand Avenue Health Centers
Provides treatment and support services to persons experiencing problems related to emotional and mental health concerns.

Special Supplemental Nutrition Program for Women, Infants and Children (WIC) Program

Available at all Health Centers except Grand Avenue
The WIC program provides health screening, referral, nutrition counseling, health education, breastfeeding support, and vouchers for nutritious supplemental foods at no cost.

Illinois Breast and Cervical Cancer Program

Free breast and cervical cancer screenings are offered to age eligible, low-income Lake County women.

Be Well-Lake County

(847) 377-8875
This diabetes prevention program provides client screening, treatment, referrals, outreach and community education on topics such as the basics of diabetes, pre-diabetes, obesity, nutrition and the importance of physical activity.

HIV/STD Program

(847) 377-8450
Provides individuals who may have or who are diagnosed with HIV/AIDS or STD's with a comprehensive visit that addresses the patient's physical, emotional and lifestyle needs.

The **Lake County Health Department** offers a number of additional programs and services, including:

- Addictions treatment and crisis care programs
- Outpatient mental health services
- Elder services
- Alcohol, tobacco and other drug prevention services
- Community nutrition
- Tuberculosis clinic
- Teen parent services
- Family case management/public health nursing
