**Sheriff's Office Weekly Arrest Press Release**  
**(January 27 – February 3, 2019)**

In an effort to increase transparency with our community, Sheriff John Idleburg announces the Lake County Sheriff's Office will begin publishing a weekly press release of arrests.

The press release will include information on the dates, locations, names, and bond amounts of individuals arrested and charged with a misdemeanor or felony criminal offense by the Lake County Sheriff's Office.

Sheriff Idleburg said, "One of my priorities is ensuring we are actively engaged with those we serve, and properly sharing information. Many Lake County municipalities publish a weekly press release to share arrest information with their community, and the Lake County Sheriff's Office should be no different. The public should be informed as to the arrests made by members of the Lake County Sheriff's Office."
