The Lake County Division of Transportation (LCDOT) is proposing improvements to the intersection of Hart Road and US Route 14 in the Village of Barrington in Lake County, Illinois. The existing intersection is signalized. The improvements will consist of traffic signal modernization, roadway reconstruction, roadway widening and resurfacing of Hart Road including the addition of turn lanes on US Route 14. Other improvements include new storm sewer, a shared use path and sidewalk, erosion control, pavement marking and signing and other related roadway items.
