NOTICE IS HEREBY GIVEN that Early Voting for the June 28, 2022 General Primary Election will commence at the County Clerk's Office in Waukegan, 18 N. County St. in the Main Lobby; starting on Thursday, May 19th and conclude on Friday, June 10th. Hours for Early Voting at the County Clerk's Office will be Monday through Friday 9:00 a.m. to 5:00 p.m. Early Voting will extend to the additional **seventeen** sites in Lake County starting Monday, June 13th through Saturday, June 25th. During the week of June 13th, hours for Early Voting for all Lake County voters are Monday through Friday 9:00 a.m. to 5:00 p.m. and Saturday from 9:00 a.m. to 2:00 p.m. The Early Voting sites with Extended Hours, will remain open Sunday, June 19th from 10:00 a.m. to 4:00 p.m. During the week of June 20th, the Early Voting sites with Extended Hours will operate from 9:00 a.m. to 7:00 p.m. Monday through Friday, 9:00 a.m. to 4:00 p.m. Saturday through Sunday, and will remain open Monday, June 27th from 9:00 a.m. to 7:00 p.m.

Grace Period Registration and voting will be offered at all Early Voting locations. Registered voters may access the Lake County Clerk's website at www.LakeVoterPower.info for information on their local Early Voting site. Local Early Voting sites, including hours, addresses and phone numbers are listed below. Each Early Voting site will serve all voters in Lake County.
