Reconstruction and widening of approximately 1.7 miles of Buffalo Grove Road between Deerfield Road and IL Route 22, and approximately 1,500 feet of Aptakisic Road at the intersection of Buffalo Grove Road and Aptakisic Road. The construction activities will include storm sewer improvements, a bike path, sidewalk, curb & gutter, and signal improvements. In stream work will include one culvert replacement underneath Aptakisic Road, west of the Buffalo Grove Road intersection, which will involve the use of a cofferdam. Areas where Aptakisic Creek crosses the project area will be protected with silt fence. Disturbed areas will be stabilized with seed and blanket.
