

Public notice is hereby given that I, Holly Kim, County Treasurer and Ex Officio County Collector of Lake County, in the State aforesaid will apply to the Circuit Court of said County on February 5, 2021, for judgment (the "Application for Judgment") fixing the correct amount of any tax and for Judgment against the lands and lots mentioned and described in the following list of delinquent lands and lots for the general taxes for the years 1910 through 2019 both inclusive, together with interest, penalties and costs due severally thereon and for taxes, drainage and special assessments due for the years 1914 through 2019 both inclusive together with interest, penalties and costs due severally thereon, and for an order to sell said lands and lots for satisfaction of all amounts due.

Said sale shall commence at 9:00 A.M. on Monday, February 15, 2021, and to continue from day to day until the same shall be completed and if for any cause such Judgment shall not be rendered then such sale shall start no more than 5 business days after such judgment shall be rendered. Registration with the County Collector is required 10 business days prior to the tax sale for all persons bidding.

Costs of sale on each tract or description of land or lot is one hundred four dollars (\$104.00). Also, interest at the rate of one and one half per cent per month will be added after June 8, 2020, plus one and one half of the first installment after August 7, 2021; plus one and one half per cent per month on half the second installment after September 8, 2021, plus one and one half per cent per month on half the second installment after November 9, 2020.
