Registration with the County Collector is required 10 business days prior to the tax sale for all persons bidding.

Also, interest at the rate of one and one half per cent per month will be added after June 8, 2020, plus one and one half of the first installment after August 7, 2021; plus one and one half per cent per month on half the second installment after September 8, 2021, plus one and one half per cent per month on half the second installment after November 9, 2020.
