### Lake County Alcohol Compliance Checks

The Lake County Sheriff's Office conducts alcohol compliance checks at Lake County liquor selling establishments. The compliance checks are designed to ensure businesses vending alcohol are not selling to anyone under the age of 21.

Of the 54 establishments tested, 11 of them sold alcohol to someone under the age of 21.
