Lake County Tobacco Compliance Checks

Last week, the Lake County Sheriff's Office concluded the first-round of 2022 tobacco compliance checks. The checks were conducted at businesses which sell tobacco/nicotine products throughout Lake County. The compliance checks are intended to ensure businesses selling tobacco/nicotine products are not selling to anyone under the age of 21.

Of the **67** establishments checked, **11** failed the compliance check, **56** successfully completed the compliance checks.
