PERMIT FEE INSTRUCTIONS

Food and Beverage Vending Machines include only those which dispense cup hot beverages; cup soft drinks; milk; ice cream; perishable foods (sandwiches, etc.); hot canned foods; bulk popcorn; bulk ice, and water.

Fees for Food and Beverage Machines:

For 1 or 2 machines at the same Account Location	\$ 40.00/year
For 3-5 machines at the same Account Location	\$ 71.00/year
For 6-10 machines at the same Account Location	\$ 110.00/year
For 11-15 machines at the same Account Location	\$131.00/year
For 16-10 machines at the same Account Location	\$169.00/year
For 21-24 machines at the same Account Location	\$203.00/year
For 25 or more machines at the same Account Location	\$240.00/year

For the purpose of determining the appropriate fee, the term Account Location shall be used. Account Location means the total number of food and beverage vending machines owned and serviced by your company that are on location at a particular account entity and address:

- Examples:
- A. Account Location is a building with one address, 150 Lake Road. Building is one account entity with vending machines in 4 locations, 2 machines per location for a total of 8 machines. Fee is \$110.00.
 - B. Account Location is 4 separate buildings but all with the same address, i.e., 200 Lake Road, Building A; 200 Lake Road, building B; etc. All 4 buildings are the same account entity and within each building there are 3 vending locations; 2 locations have 2 machines each and one location has 4 machines for a total of 8 machines per building. The total number of machines at this Account Location is 32. Fee is \$240.00.

The total permit fee for a vending company is determined by adding up the individual fees for each of the company's Account Locations. Using Examples A and B above, the total permit fee for a vending company with just these two Account Locations would total \$350.00.
