EARLY VOTING

NOTICE IS HEREBY GIVEN that Early Voting for the March 20, 2018 General Primary Election will begin at the County Clerk's Office on Thursday, February 8 and continue through Friday, March 2 during the hours of 9:00 a.m. to 5:00 p.m. Monday through Friday. Early Voting will extend to the additional **fifteen** sites in Lake County starting Monday, March 5 and end on Saturday, March 17. During the weeks of March 5th and March 12th, Early Voting hours for Lake County are 9:00 a.m. to 5:00 p.m. Monday through Friday, and 9:00 a.m. to 2:00 p.m. on Saturday. The four State Mandated Early Voting sites will remain open 10:00 a.m. to 4:00 p.m. on Sunday, March 11th. For the week of March 12th, the four State Mandated Early Voting sites will extend their hours to 7:00 p.m. Monday through Friday, and operate from 9:00 a.m. to 4:00 p.m. on Saturday and Sunday. Additionally, the four State Mandated Early Voting sites will operate from 9:00 a.m. to 7:00 p.m. on Monday, March 19th.

Grace Period Registration and voting will be offered at all Early Voting locations. Registered voters may access the Lake County Clerk's website at www.LakeVoterPower.info for information on their local Early Voting site. Local Early Voting sites, including the hours, addresses and phone numbers are listed below. Each Early Voting site will serve all voters in Lake County.
